Proposal: As part of outreach efforts, AGW could host candidates for local elections at neighborhood meetings so that Amberglen residents could become better acquainted with them. These could be held at someplace like Chuck's Markets. Should we have Chuck and Karen come up with a plan and notify the steering committee at the next meeting?	Accepted
Proposal: Plans for the AGW community bench have been posted on TownSq. Should we have Deb gather community comments and send them to steering committee members for comment?	Accepted
Proposal: The AGW community safety event is currently scheduled for August 24, which is nonvenient for Sue, the project coordinator. Should we change the event date to August 31?	Accepted
